Juristat's Top 100 Patent Firms list is the only ranking of U.S. law firms based on those firms' objective performance in front of the USPTO. Our analysis comes from Juristat's dataset of over 7 million patent applications and is based on a weighted average of the following four criteria:

- 1. Total number of applications filed*
- 2. Allowance rate**
- 3. Average number of office actions to allowance**
- 4. Average time to allowance**

After the firms' rankings were calculated for each criterion, we calculated an overall ranking by determining a weighted average of each firm's four rankings.

It is important to note that the below rankings are only one way to measure performance and are not intended to be definitive. There are many different areas in which a firm may excel, which this particular list may not encompass. Juristat's subscribers can obtain in-depth analysis of law firms' performance in individual art units, tech centers, or before the PTAB and customize those results to their individual needs.
